Entries close January 14, 2021 All mailed entries must be post marked by January 14, 2021 and emailed entries sent by January 14, 2021. ANY ENTRIES AFTER JANUARY 14, 2021 WILL BE ASSESSED APPLICABLE LATE FEES.

Pre-entries must include \$75 stall fee. Refund and Substitution information below.

Refunds of entry & stall fees will only be considered in the event of death or serious injury of the equine entered. A signed & dated vet certificate must be presented to show office no later than 5:00 PM on afternoon prior to first class entered. Any occupied stall is NON REFUNDABLE. Refunds will be sent to agent who paid entry fee(s). NO refunds for scratched entries. Should the Dixie National Color Bonanza 2021 be canceled due to Covid 19 restrictions by state or federal governments before start of the show, monies will be refunded.

Substitutes will be considered due to lameness, injury or death. **Any extenuating circumstances will be ruled upon by the Show Manager.**

*Late entries are accepted at the show office during the show only. The penalty for a late entry at the show is \$50 per horse.

All late fee entries must be received no later than 1 hour before the first class of the day.*

-- Entries may be paid by check, cash, or money order. --

-- All forms of payment are to be in U.S. funds. --

-- Entries are not officially made until payment clears. --

-- A \$50 processing fee will be charged for any returned check. --

Copies needed to process entries

1. Current registration papers or eligibility papers
2. Current Applicable Membership cards for OWNER and EXHIBITOR.
3. Copy of show record or ROM proof for Performance Halter

All persons present will comply with current Mississippi mandates regarding PPE during horse show.

Two entries constitute a class.

OWNERS and EXHIBITORS must have current memberships and eligibility with PHBA &/or PTHA, &/or ARHA, &/or NASMDA for horse to show in registered classes.

FEES for ALL

Office Fees:	\$25 per equine
Stalls:	\$75 per circuit
Shavings:	\$10 per bag (Stalling office)
Grounds Fee:	\$15 per day

RV spots are not reserved & will be paid directly to Fairgrounds.

Stalls will only be reserved WITH payment on a First come, First reserved basis. To stall as a group, reservations must be sent together with payment & one person designated as "Stall Agent." NO OUTSIDE SHAVINGS ALLOWED as per MS Fair Commission. Shavings are \$10 a bag through the Stalling Office.

All classes \$10 per equine/per judge Flat fee= one stall and all classes for one equine's entry
\$250 flat fee per equine per association with pre-registration includes STALL but NOT each association's fees.
\$100 max fee per equine for second association but NOT the association's fees.
\$50 max fee per equine for third association but NOT the association's fees.

Open will use back numbers 400-499.	PHBA regular registry must show PHBA Papers & current memberships. PHBA will use remaining back numbers.
ARHA must show papers & current membership. ARHA will use back numbers 900-999.	NASMDA must show papers & current membership. NASMDA will use back numbers 800-899.	All PHBA classes will also be Open show classes.	

ATTENTION ALL EXHIBITORS: The MS Board of Animal Health requires that ALL equines entering the MS Fairgrounds, that are 12 months of age or older must have & present a current (12 months) negative EIA (Coggins) report AND a 30 day Certificate of Veterinary Inspection (Health Certificate). Original only, NO PHOTOCOPIES accepted. Certificates will be checked at Gate 14 (Livestock Gate).
